All entries must be uploaded via the Judgify portal by the closing date.

The Judgify portal does allow you to save your progress and submit the final version when you are ready.

PROJECT NAME:

Executive Summary

Weighting: 10% Word count: 150 words maximum Provide an overview/summary of your project/initiative/product or service.

Hint: This is your big opportunity to grab the attention of the judges - tell them why you deserve to win. Things you may want to cover could include: the problem you solved, key statistics, and enough background/context so the judges can understand your market position.

Project Scope

Weighting: 10%

Word count: 500 words maximum

Introduce the project/initiative scope. What kind of project were you working with/on? What need or purpose were you addressing? What constraints were you operating within? Were you aiming to realise significant savings or meet/ exceed industry benchmarks?

Hint: This section doesn't necessarily focus on the outcomes of your project, but is important to set the scene and illustrate the context.

Project Quality

Weighting: 10%

Judges will be comparing overall quality of the submissions in each category. So to maximise the impact of your submission, run a quality check. Did you answer all the questions fully? Did you address the subject of the questions, or stray from the subject? If pictures or specs help with context, did you include them? (note: attachments are not weighted).

Hint: Getting this criteria right is an easy way to add 10% to your overall score!

As this is the Productivity category, make sure you're specific about how your methodology played a part in improved productivity.

Word count: 250 words maximum

Tell us how your solution or service is different from what's already on the market. How does it help or improve the industry? How does it enable projects to be delivered more efficiently?

Outcomes

Weighting: 30% Word count: 250 words maximum Describe the outcomes you achieved for your client.

Hint: hard numbers and statistics are what count here - quantify the time or cost that you saved, or the decrease in downtime (for example).

Key Accomplishments

Hint: hard numbers and statistics are what count here - clear and measurable benefits or changes for your employees, community or potential employees.

Provide examples or case studies of how this product/ service can increase (or will increase) productivity, efficiency and/or cost savings.

Hint: hard numbers and statistics are what count here - clear and measurable outcomes from your collaborative efforts, in terms of time or cost saved, productivity improved or potential for savings.

CONDITIONS OF ENTRY

The following conditions of entry apply for all applicants:

- Entry is open from Monday 19 January 2024 to 5:00PM Friday 26 April 2024.
- Entries and all supporting materials must be uploaded to the QMA Judgify platform by 5:00PM Friday 26 April 2024. No late entries will be accepted.
- Applicants must meet all Entry Criteria to be eligible.
- Entries must address the criteria applicable to the category and provide supplementary information as requested.
- All entries must be fully completed and uploaded on the Judgify platform to be eligible.
- Digital media can be uploaded to support entries. However, this type of supporting documentation will not contribute to the weighted assessment criteria and will be used for information purposes only.
- Projects/Initiatives must have been developed in Queensland or deployed in Queensland during the period April 2022 to April 2024.
- Projects that are partially completed or ongoing may still be eligible. The entry must be able to demonstrate significant, quantifiable milestone achievements within this timeframe, and will be assessed on a case-by-case basis.
- The same project can only be entered in a maximum of two separate categories.
- Each entry must be entered entirely independently (i.e. separate to another entry made by the same company).
- The entrant is responsible for the accuracy of all supplied information.
- Entrants may be asked to provide further documentation or evidence to support their application.
- Entry fees (as applicable) must be paid per category at time of entry via the Awards website and are non-refundable unless exempt below. Paid entries include one ticket to the QMA 2024 Gala Dinner.
- Entry fees are not payable for QME Exhibitors or Not for Profit Organisations.
- Those entrants who are shortlisted will be notified prior to the Awards Presentation Night, which will be held on Wednesday 24 July 2024 in Mackay as part of QME.
- Judges will select up to four category finalists and one category winner for each category. Judges will also award a 'Mining Contractor of the Year Award' chosen from the contractor/supplier finalists across all categories.
- The Judges' decision is final, and no further correspondence shall be entered into.
- A representative from each finalist company is required to attend the Gala Awards Presentation Night held on Wednesday 24 July 2024.
- BBMC reserves the right to distribute media and BBMC-owned images for publicity purposes pertaining to the BBMC 2024 Queensland Mining Awards. No confidential information received as part of an entry nomination will be disclosed.
- All applications are held and treated in the strictest confidence.
